

MEMBERSHIP TERMS AND CONDITIONS

OBJECTIVES:

The objectives of the Association, apart from overseeing the overall interests of its Members, are:

- a) To promote interest in the sport of Cowboy Challenge.
- b) To promote good fellowship among those interested in the sport.
- c) To educate and encourage members of the Association.

CODE OF CONDUCT:

It is expected that all members abide by the Rules of the Association at all times and conduct themselves in a polite and orderly manner being friendly, supportive and respecting other members of the Association and the authority of Officials and Organisers. The NCCA has strict policies in place in regards to members behaviour. Any members found to be bullying, harassing or disrespecting others or making comments of a defamatory or disparaging nature towards other members, Officials and Organisers or the Association in person or online including through social media platforms will be removed from the Association. Complaints regarding individuals breaching the Association's Rules or Code of Conduct shall be brought before the NCCA Board of Directors, which may result in suspension from Competition or revoking of Membership, no refund will be given.

GENERAL RULES:

- The NCCA's financial and competition year runs from 1st January to 31st December.
- Membership is available to anyone 5 years of age or older.
- Junior Membership is 5-17 years of age.
- All memberships are subject to approval by the NCCA Board of Directors.
- You must be a member of NCCA to compete at any NCCA events otherwise a day membership must be obtained. Day members are only eligible to compete in Open/Rookie level classes.
- Members will be notified of any amendments made to the rules as they occur and an updated copy will be available from (website). It is the responsibility of the members to know the Rules and Regulations of the Association. Ignorance of the Rules is no excuse.
- Your membership is only valid for the term of your membership and does not renew automatically. Members will be required to purchase a new membership on the expiration of their membership should they wish to remain a member of the Association.

Membership fees are as per the competition year from 1st of January, all member fees are to be paid on or prior to this date. A pro rata membership will apply after 30th of June in the competition year.
